- 3. Type of public procurement procedure:** Local open procedure
- 4. Nature and scope of works and basic characteristics of works, place of execution of works, title and index from the general procurement vocabulary:** Construction of the building of judiciary bodies in Kragujevac for accommodation of: Basic Public Prosecution in Kragujevac, Higher Public Prosecution in Kragujevac, Appellate Public Prosecution in Kragujevac, Basic Court in Kragujevac, Higher Court in Kragujevac, Appellate Court in Kragujevac, Misdemeanor court in Kragujevac, Commercial Court in Kragujevac, Misdemeanor Appellate Court – Department in Kragujevac, Administrative Court – Department in Kragujevac and State Attorney’s office – Department in Kragujevac.

- 5. Contract award criterion:** Lowest price.
- 6. 7. **Submission of bid and deadline:** The bidder shall submit the bid personally or by post. Regardless of the manner of submitting a bid, the bidder must ensure that the bid is received at the Employer's Registry Office not after June 1, 2018 till 11.00 am, at following address: Ministry of Justice, 22-26 Nemanjina street, 11000 Belgrade. The bidder shall submit a bid in a sealed envelope or certified sealed box. On the front of the envelope/box, the bidder shall paste filled Cover Form (Form 1).

8. **Place, time and method of bid opening:** Bid opening will be held at June 1 2018, at 11:30 am, in Ministry of Justice, 22-26 Nemanjina street, 11000 Belgrade, 4<sup>th</sup> floor, room 31. Bid opening is public and any interested person can be present.

9. **Conditions under which the bidders representatives can participate in the bid opening procedure:** Only the authorized representatives of the bidders can actively participate in the bid opening procedure. Prior to the opening of bids, the representatives of the bidders are obliged to submit written authorizations to the Commission on the basis of which they will prove the authorization for participation in the bidding procedure.

10. **Deadline for decision making:** Deadline for decision making is 25 days counting from the day of bids opening.
